## New Business:

Lisa Lane residents: Residents of Lisa Lane were present to discuss the water problems on the road and request paving. A meeting will be set up with DPW foreman and Naegele at the site.

Gus DePietro -134 Gravel Pond Road: Mr. DePietro brought his concerns over the property located at 1335 Gravel Pond Road having loose garbage all over the property that blows everywhere and even in the creek. Haan has been to see the property owner who will cooperate to get the property cleaned up but has not done so yet. Sheils will send a letter to the owner with a time frame.

Standing Committee Reports: POSTED - Planning Commission

Recreation Center: The committee reported on the rentals, meeting, activities and the building status. They received an estimate to repair the floors from the water damage last year. Daydreamers requested they look at other floors where they rent but refuse to pay to have them fixed from the wear and tear that they caused. Committee is going to recommend that window air conditioners not be used due to the stress on the windows. By-law changes still have to be submitted to the Board for review. Committee is working on getting estimates on building repairs. Community feed back is requesting that the

gym be returned to use. The grand opening is scheduled for September 23, 2023. May 21, 2023 there will be a book club meeting, paint and sip and line dancing.
